account registration

- ▶ Log into the MCCF Home Page at:
 - ▶ <https://mccf.biz/>
- ▶ Don't have an account? Complete the following steps to setup your MCCF account:
 - ▶ Click on the "Members Only Login"
 - ▶ Click on the "Register here!" button under "Not a Member" at the bottom of the screen. *Even if you are already a MCCF Member, the Steering Committee asks that you setup an account through our updated website, this will be required to access both the Discussion Board and File Cabinet*
 - ▶ Complete the Site Registration fields and click "Register"
 - ▶ *Note: It is our intention to approve and grant access as quickly as possible, but it may be a day or two before your request is processed. Also, please watch your Spam/Junk Mail folder for notices from the MCCF Website*
 - ▶ *You must use your company email address. Requests from personal email accounts will not be processed.*

We limit the ephemeral port range the OS can possibly use by setting it using the NETSH command. Once the range is limited to a smaller scope, then the range associated with the specific service running under svchost.exe can be used to build your baseline. 
